INFORMATION PURSUANT TO EU REGULATION 2016/679 ON PERSONAL DATA PROTECTION

Pursuant to art. 13 of EU Regulation 2016/679 of the European Parliament and Council concerning the protection of individuals with regard to the processing of personal data, as well as the free circulation of such data, which repeals Directive 95/46/EC (General Data Protection Regulation, or GDPR), we inform you that the personal data provided, including your image and/or that of the minor, will be processed in print and online in compliance with current regulations and the principles of fairness, lawfulness, transparency and confidentiality. Your image and/or that of the minor may be transferred to third countries by posting to social media platforms.

Your consent to personal data processing is optional. However, failing your consent, we will not be able to take your picture. Pursuant to arts. 15 to 22 of the GDPR, you have the right to ask for access to your or your child's personal data, rectification or cancellation of the same, limitation of processing, to oppose to data processing or data portability, by sending a written notice to the author of the photograph.

If you believe that personal data processing occurs in violation of the provisions of the GDPR, you have the right to lodge a complaint with the Data Protection Authority as required by art. 77 of the Regulation or to file a petition before the appropriate judicial authority pursuant to art. 79 of the Regulation.
